### Report of the Council on Nominations

1 The Council on Nominations met on Tuesday, March 5, 2024, by Zoom conference.  
 2 Minutes of the meeting are on file in the NYSDA Headquarters office, and have been  
 3 distributed to the Board of Trustees and to component presidents, presidents elect,  
 4 executive directors and council chairs.

 6 In accordance with Chapter VI, Section 30 of the *Bylaws*, a "Call for Nominations"  
 7 describing the elective offices to be considered by the 2024 House of Delegates and the  
 8 eligibility requirements thereof was published on the NYSDA website and in the  
 9 November 2023 issue of the *New York State Dental Journal*. All nominations received  
 10 were evaluated to determine if the nominee was eligible for the office being sought in  
 11 accordance with Chapter VI, Section 20 of the *Bylaws*. The following reflects the  
 12 recommendations of the Council:

 14 **Candidates for Elective Offices:**

 16 *President-elect*: The name of Dr. Maurice L. Edwards (New York County Dental  
 17 Society) was duly submitted as a candidate for the office of President-elect and deemed  
 18 eligible to serve by the Council on Nominations.

 20 *Vice President*: The name of Dr. Amarilis Jacobo (Bronx County Dental Society) was  
 21 duly submitted as a candidate for the office of Vice President and deemed eligible to  
 22 serve by the Council on Nominations.

 24 *Secretary-Treasurer*: The name of Dr. Paul R. Leary (Suffolk County Dental Society)  
 25 was duly submitted as a candidate for the office of Secretary-Treasurer and deemed  
 26 eligible to serve by the Council on Nominations.

 28 **Recommendations for Elective Offices:**

 30 *President*: **Dr. Prabha Krishnan** (Queens County Dental Association) automatically  
 31 ascends to the office of President at the next installation, in accordance with Chapter VI,  
 32 Section 70 of the *Bylaws*.
